THE OPPORTUNITY

This is an opportunity to support and deliver aquatics-related programming that supports decision-making to protect lands and waters on the First Nation of Na-Cho Nyäk Dun (FNNND) traditional territory (TT). Duties would include collection of aquatic ecosystem data, organizing and interpreting the data, and reporting findings to FNNND, stakeholders, and/ or territorial and federal agencies. Aquatics programs could include water chemistry and flow, fisheries, aquatic invertebrates and algae, sediment quality, and riparian vegetation. It is a position that supports the Lands Department's stewardship of TT as well as long-term initiatives, by providing technical aquatic support to a variety of files and projects.

THE PERSON

You are someone who has wilderness travel skills and a willingness to be in the field in all seasons who likes to work on aquatic projects related to water strategy, environmental assessments, and land use planning. You are knowledgeable of the Umbrella and FNNND Final Agreements and have experience working with local traditional knowledge and western science and desire to ensure both contexts are presented in a balanced manner, particularly when conducting scientific analysis and research.

QUALIFICATIONS

You have a degree or diploma in Biological or Environmental Sciences, or related field with 3 -5 years experience in aquatic science. You are experienced in researching, gathering and interpreting technical information and reports in project assessments, and/ or resource management related planning, or similar (environmental assessment context preferred). You demonstrate experience working collaboratively with government agencies, First Nations, industry, consultants, and non-government organizations on land and resource issues, development activities, legislation and regulations affecting Yukon First Nations.
